

WIND FARM BIJELA

PROJECT OVERVIEW



Wind Farm Bijela is a large-scale renewable energy project situated in the highlands of **Šavnik**, Montenegro. The project is owned by **Alcazar Energy**, a company with a proven track record in sustainable infrastructure and clean energy investments.

- Owner: Alcazar Energy / Vjetro park Bijela
- Location: Municipality of Šavnik, Montenegro, with smaller areas in Nikšić, Plužine and Kolašin
- Type: Onshore wind power
- Goal: Deliver clean, affordable electricity to the Montenegrin grid
- Capacity: 118 MW, 17 turbines
- Generation: 320GWh per year, equivalent to power over 16,000 households
- Access roads: 16 kmOHL: c.a. 18 km
- 700+ landowners, 300+ contracts

WHY THIS PROJECT MATTERS

Montenegro has set ambitious targets under its National Energy Strategy, and Bijela Wind Farm directly supports those goals. As the country advances toward a greener, more secure energy future, this project provides the infrastructure and capacity needed to accelerate that energy transition. It is a strategic investment in Montenegro's long-term economic resilience and energy sovereignty.

ENVIRONMENTAL AND SOCIAL RESPONSIBILITY

Bijela Wind Farm is developed in full compliance with **national laws** and **international best practices**, particularly the **Environmental and Social Performance Standards** of institutions like the **EBRD and IFC**. Sustainability is at the core of our practices across all phases of the project.

The approach is bound in transparency, responsibility, and respect:

Environmental protection:

- o National Environmental Impact Assessment (EIA) process.
- o International Environmental and Social Impact Assessment (ESIA) process.
- Commitment to protect biodiversity and minimize ecological disturbance through detailed and independent environmental assessments and mitigation measures to national and international standards.

Respect for people and land:

- o Land acquisition process is conducted through voluntary, informed and negotiated agreements
- o All affected landowners are treated with fairness, dignity and respect, following a standardised framework.
- o Independent property valuation undertaken to ensure fair market compensation.
- o No construction prior to full compensation being paid.
- o Legal support and documentation throughout the process.
- o Resettlement Action Plan (RAP) currently being developed, focused on restoring or improving living standards of all affected persons.

Expropriation when necessary

- o Expropriation is always our last resort and would only be triggered in a limited number of cases where voluntary agreements are not feasible after multiple efforts (deceased, inheritance cases could not be initiated or finalised...).
- o Legal safeguards and compensation mechanisms are guaranteed.

Inclusive Community Engagement & Grievance Process:

- o Community Liaison Office (CLO) in Šavnik available for continuous, open communication and dialogue.
- o Regular public consultations, field visits, and stakeholder briefings.
- o Dedicated anonymous online grievance mechanism.
- o All feedback is documented and addressed in a timely, respectful, and transparent way.

Community dialogue is a continuous relationship and partnership based on transparency and mutual respect.

SHARED BENEFITS - FOR ALL STAKEHOLDERS

This project is designed to deliver tangible, measurable and long-term benefits at three levels: **community, municipal, and national.**

FOR LOCAL COMMUNITIES:

- **Employment opportunities** during construction and operation.
- **Skills development** and training for youth involved in the project.
- Potential infrastructure upgrades (e.g. roads, access, communications).
- Support for local entrepreneurs and farmers and initiatives in eco-tourism, education and environmental stewardship through social development and investment programs.

FOR THE MUNICIPALITY:

- Tax revenue and yearly fiscal contributions (1% of asset tax) to the municipal budget (Šavnik).
- Memorandum of Understanding with schools and institutions to support local development.
- Strengthening municipality position as a regional example of renewable energy transition.

FOR THE COUNTRY:

- **Diversification of energy sources** to strengthen energy independence.
- Contribution to EU-aligned climate goals and emissions reduction.
- Attraction of sustainable foreign direct investment (FDI).
